

Terms and Conditions

1. Introduction

The free trial ceases once your balance reaches \$300. To continue using the system, you must deposit at least \$50.

4. Deposits, Withdrawals, and Trading

Deposits and withdrawals can be made through various payment methods. Users are responsible for all deposit and withdrawal fees, as well as for ensuring that all deposits and withdrawals comply with legal requirements.

5. Risks and Liabilities

a. Trading cryptocurrencies involves significant risk and can result in the loss of your invested capital. You should not invest more than you can afford to lose. b. You acknowledge and agree that you are solely responsible for understanding and complying with all laws, rules, and regulations relating to your trading activities. c. EuroProfits is not liable for any losses or damages arising from the use of its Services, including, but not limited to, losses from market fluctuations.

You agree to use the Services responsibly and not engage in activities that could impair the functionality of the Services. This includes, but is not limited to, distributing viruses, spam, or conducting any form of illegal activity.

The parties agree to attempt to resolve any dispute amicably before proceeding to arbitration.

EuroProfits reserves the right, at its sole discretion, to modify or replace these Terms at any time. If a revision is material, we will make reasonable efforts to provide at least 30 days' notice prior to any new terms taking effect.
